

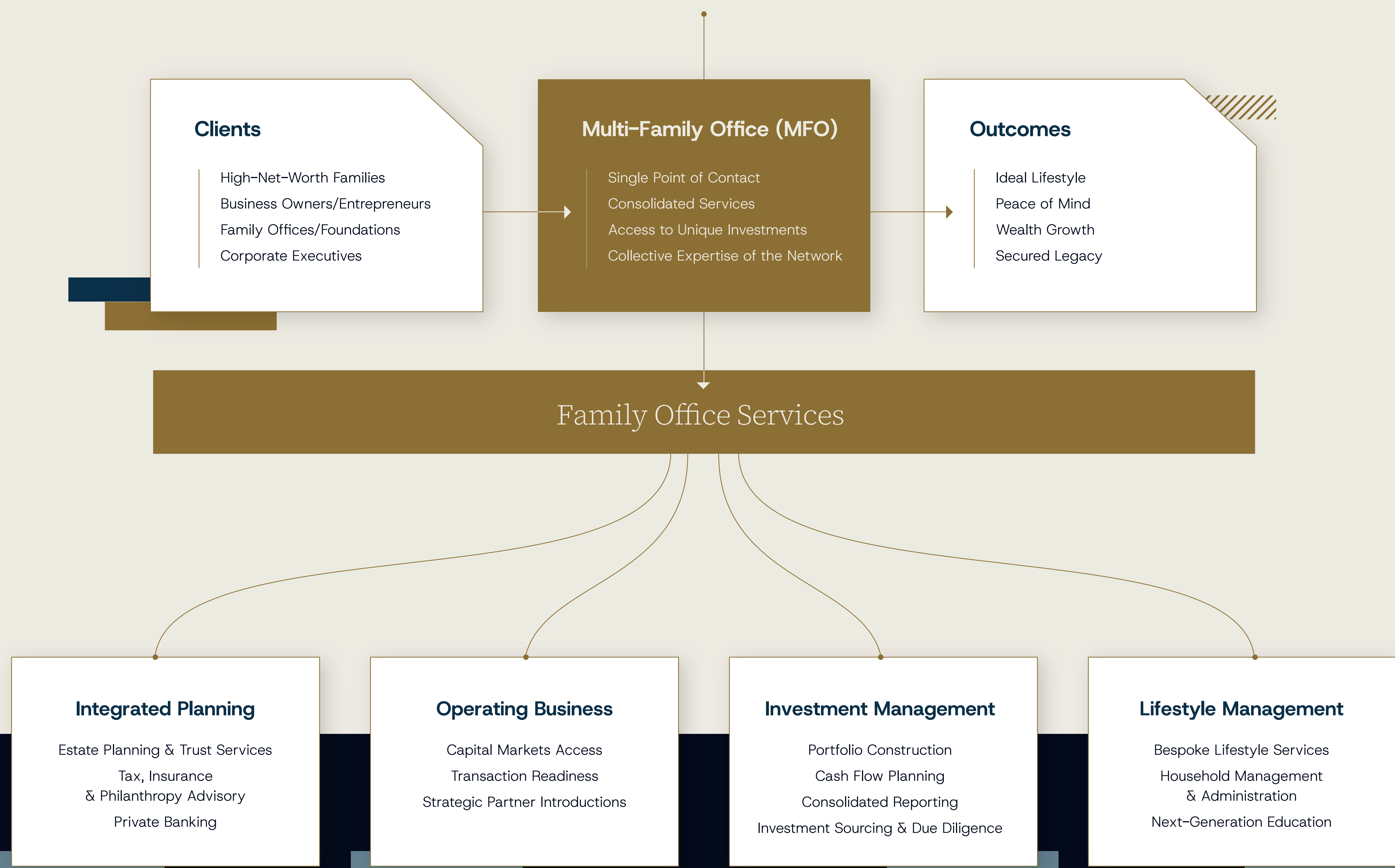
What Is a *Multi-Family Office*?

A multi-family office, or MFO, provides a diverse suite of consolidated services to simplify the lives of high-net-worth families and help them secure their legacies for generations.

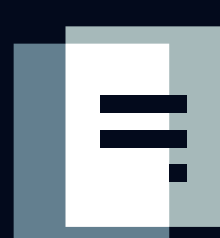
